

Industrial Designs (Amendment) Regulations, 2025 (No. 17)

IT is hereby notified that the Minister of Justice, Legal and Parliamentary Affairs has, in terms of section 58 of the Industrial Designs Act [Chapter 26:02] made the following regulations:—

*Title*

1. These regulations may be cited as the Industrial Designs (Amendment) Regulations, 2025 (No. 17).
2. The First Schedule to the Industrial Designs Regulations, 1972, published in Statutory Instrument 211 of 1972, is repealed and the substitution of—

### Notes

1. For local applicants the fees may be payable in Zimbabwean dollars at the prevailing bank rate.
2. For foreign applicants all fees are payable in United States dollars.
3. Where the applicant is claiming a Research Institution/Academic Institution/ Student/ SME rate they are required to complete and submit together with the application form a declaration of entity form as gazetted in this Statutory Instrument.
