## Road Traffic (Licensing of Drivers) (Amendment) Regulations, 2022 (No. 35)

IT is hereby notified that the Minister of Transport and Infrastructural Development has, in terms of section 81 of the Road Traffic Act [Chapter 13:11], made the following regulations:—

- 1. These regulations may be cited as the Road Traffic (Licensing of Drivers) (Amendment) Regulations, 2022 (No. 35).
- 2. Section 12 of the Road Traffic (Licensing of Drivers) Regulations, 1977, published in Rhodesia Government Notice No. 240 of 1977, as amended by Road Traffic (Licensing of Drivers) (Amendment) Regulations, 2021 (No. 34), published in Statutory Instrument 40 of 2021, is hereby repealed and substituted with the following—

## "Prescribed fees

- 12.(1) A person applying in terms of section 8(2)(b) or (3) of the Act to an issuing officer for a tractor driver's permit or duplicate tractor driver's permit shall transmit with their application a fee of fifteen United States dollars (US\$15,00).
- (2) The fee to be remitted to the Registrar by a farmer or miner or their manager or a registering officer in terms of section 8(5) of the Act, shall be a fee of fifteen United States dollars (US\$15,00).
- (3) A person applying in terms of section 9(1) of the Act to an examiner of a learner's licence shall transmit with their application a fee of twenty United States dollars (US\$20,00) for testing the applicant.
- (4) A person applying in terms of section 10(1) of the Act to an examiner for a Certificate of Competency shall transmit—
  - (a) with their application a fee for testing the applicant in respect of a Certificate of Competency for—
    - (i) class 3 or 4 vehicles a fee of twenty-five United States dollars (US25,00);
    - (ii) class 1, class 2 or class 5 vehicles a fee of thirty United States dollars (US\$30,00);

- (b) upon the successful completion of the test, a fee of fifteen United States dollars (US\$15,00).
- (5) A person applying in terms of section 14(1) of the Act to the Registrar shall transmit with their application for—
  - (a) duplicate learner licence, a fee of fifteen United States dollars (US\$15.00);
  - (b) an international driving permit, a fee of one hundred United States dollars (US\$100,00);
  - (c) search fees, a fee of five United States dollars (US\$5,00);
  - (d) a duplicate driver's licence, a fee of fifteen United States dollars (US\$15,00);
  - (e) an urgent driver's licence, whether original or duplicate, a fee of fifty United States dollars (US\$50,00).
- (6) An examiner receiving a fee referred to in subsection (3) or (4) shall issue to the applicant a receipt in form R.T.L.D.8.
- (7) A person applying in terms of section 19(1) of the Act to the Registrar for a driver's licence shall transmit with their application, a fee of one hundred United States dollars (US\$100,00).
- (8) The fees stipulated above may be payable in local currency for local drivers at the prevailing interbank rate of the day.
